Criterion Met: No Reporting Period: 2012-2013	09/28/2012 - Sept., 2012 - measurements were taken of the three rooms to renovate for ADA compliance in summer, 2013, and architectural plans to build a fourth ADA compliant room in the new wing were presented to the Housing Advisory Board. Construction on the new addition was to begin January, 2013, but is now on hold due to a lack of funds. Follow-Up: 04/01/2013 - Current occupancy loads require 2 ADA rooms and will be addressed as soon as funds are available or the remodel begins.
