- Applications must include:
 - A copy of your high school or college transcript
 - Two letters of reference/recommendation
- Applicant must be a resident of Nevada.
- Applicant must already be enrolled in a post-secondary program or will be enrolling and attending an institution of higher education within the year.
- Preference given to students pursuing an education in agriculture, renewable natural resources or a related field. Scholarships will be awarded at the NvACD Scholarship Committee's discretion. Multiple scholarships may be awarded.
- Scholarship money is to be used for schooling expenditures at an accredited institution of higher learning, including vocational/technical schools. The funding must be used within the immediate year of attendance after the scholarship is awarded towards tuition and fees, room and board, books, school supplies, or transportation.
- Before any scholarship payment is made, the successful student must provide proof of enrollment to NvACD for review. Payment will then be sent to the financial aid office of the appropriate institution.
