#### **Item #1: Approval of Meeting Notes**

a. Meeting notes for September 11, 2015 were approved.

#### **Item #2: Spring 2016 Accelerated Math Course Offerings**

a. John Newman provided an update on the NSHE Gateway Pilot Program. The program is going well. To be successful in the accelerated program, students must stay motivated, disciplined, engaged and organized. Full implementation of the program is mandatory and will occur during fall 2016. A handout was distributed for advising purposes and chairs were asked to share the information with their departments. For the spring 2016 semester, the following online math course sequences will be offered:

#### **Eight Week Courses**

**Semester Long Course** 

- ✓ Math 095 1st Eight Weeks
- ✓ Math 120 1st Eight Weeks
- ✓ Math 120 2nd Eight Weeks
- ✓ Stat 152 2nd Eight Weeks

- ✓ Math 126E Semester course
- b. MATH 126E is the same as MATH 126 except that it includes additional remediation and it's a five-credit course. Students receive three credits for MATH 126 and two credits will be considered as electives.

#### **Item #3: Prioritization of Faculty Positions**

- a. Health Science and Human Services will provide a written justification to rehire for the instructor/coordinator position for human services and will be present the document at the November meeting. A suggestion was made to incorporate counseling duties into the position.
- b. At the November meeting, a wish list of teaching faculty positions will be generated. Written justifications, including FTE and graduation rates, will be needed to proceed with the process. Positions that are funded by soft money should be included in the requests.

#### Item #4: Follow-up Discussion on President's Recommendations

a. The CTE Chair shared a response from the area, the response was stated as follows:

The main concern should be the welfare of the students. Programs and degrees should provide students with gainful employment and should be the main goal. It is important to graduate students with skills that will get them paid.

- b. Information pertaining to the funding formula can be found on the NSHE website.
- c. Concerns were voiced that both the VPSS and VPAA already have enormous workloads and combining the positions will lose focus on student issues and many items will fall through the cracks. Combining the positions will be both hard and stressful; especially with moving towards a state college and offering more four-year degrees. The concerns will be discussed with the president at a meeting that is scheduled for October 12.
- d. The Veteran's Resource Center has been very successful and Jacob Park was acknowledged for the excellent work that has been accomplished. It was suggested that a center, for all students, to participate in should be incorporated into GBC's growth plan.
