The sweaters would be customizable to the student's degree. Senator La Riva said students in the dual-enrollment program are also interested. Senator Stillian was interested and asked for a price list.

Student Advocate Garcia said that Vice President Sibert should be contacted to discuss whether the idea is feasible since it would involve SGA funds and collecting money from the students.

Senator Sturges recommended creating a poll or contacting professors in different departments to see if there is enough interest.

Senator Mersino said that students in the Land Surveying and Geomatics program would be interested. Senator Sanchez asked SGA officers to contact him with any other interest.

Senator Sturges asked if they would be like the sweatshirts sold in the GBC bookstore. Student Advocate Garcia reiterated reaching out to Vice President Sibert. Pat Anderson agreed so as not to compete with the bookstore. She asked what companies Senator Sanchez has looked at for pricing. Senator Sanchez is using CustomInk. Pat Anderson said that if the sweatshirts are customizable, the price will be affected. Senator Sanchez said that if more officers are interested, the price will go down.

Student Advocate Garcia said that in 2019 officers purchased t-shirts from the bookstore and distributed them to students. She offered to give Senator Sanchez the bookstore's contact information.
