## A motion to approve the minutes of November 21, 2024, was made by Trustee Roden, seconded by Trustee Morris, motion passed unanimously.

5. President's Report – Interim President Amber Donnelli. INFORMATION ONLY – NON ACTION ITEM

Interim President Donnelli may give an update on GBC matters.

President Donnelli reported the governor's budget includes a new funding formula that could give Great Basin College (GBC) an extra \$2.6 million. However, changes to the Small Institution Factor (SIF) will lead to a \$220,000 shortfall in the first year, followed by a \$270,000 increase in the second year. We believe the new funding formula will benefit GBC long-term. We will keep you updated on any developments as we navigate this situation.

President Donnelli discussed the funding formula and recent changes. She said she is not too worried about the \$220,000 reduction because of the almost a 17% increase in enrollment last fall. This spring, our Full-Time Equivalents (FTE) are up about 3%, and our Full-Time Equivalent Students (FFTE) rose nearly 11%. She stated spring enrollment has not increased as much. Ms. Donnelli stated their registration fee revenue is over \$500,000 more than planned.

Chair Colon asked where the growth is taking place? President Donnelli reported our strongest programs are in Career and Technical Education (CTE), including diesel, electrical, welding, instrumentation, and industrial maintenance, which are funded at a 1:4 ratio. Health Sciences programs are funded at a 2:4 ratio, while general education classes receive 1:1 funding.

President Donnelli reported they are looking for a new CFO as the temp CFO's contract ended in January. She reported that TMCC signed a three-month MOU to help us out. She reported that they are splitting Jake Rivera's role into two positions: Vice President of Academics and Vice President of Student Affairs. We will start the search for the new Vice President of Student Affairs in late spring, with assistance from a search firm.
